ORDER :

Ms.No.114, Dt:27.08.2008 only, i.e., the applications received and pending at Distribution Company Offices/AP.Transco Corporate Office be considered subject to implementation of Sprit of Presidential Order and also as per the orders issued from time to time. Further, it is also ordered that the representations received subsequently to the above said date (i.e. 27.08.2008) need not be considered in future and there will be no transfers from one company to another and also from DISCOMs to APTRANSOCO and vice versa in future.

5. The absorption of services of an employee on transfer from one company to another company is subject to the conditions mentioned in the T.O.O (Addl.Secy-Per) Ms.No.35, dated: 13.05.2005.
